# WAIVER/RELEASE OF LIABILITY

PLEASE READ CAREFULLY BEFORE SIGNING.  
THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

**Waiver:** In consideration of Participant's enrollment in a tennis program and/or Participant's use, today and on all future dates, of the property, facilities owned or operated by, and services of Planet Swim LLC (*from here on referred as "Planet Swim"*), Participants, Participant's heirs, personal representatives, or assigns, hereby release, waive, discharge, and covenant not to sue, Planet Swim, its affiliated companies and each of its directors, officers, employees, volunteers, sponsors, independent contractors, and agents from liability from any and all claims arising from the negligence of Planet Swim or any of the aforementioned parties. This agreement applies to (1) personal injury (including death) from accidents, injuries or illnesses arising from participation in various activities including, but not limited to, participation in sport programs, travel, competition, educational classes, lessons, social activity, and individual use of facilities, premises, or equipment; and (2) any and all claims resulting from the damage to, loss of, or theft of property. Trespassing is not permitted on to the property.

**Indemnification and Hold Harmless:** Participants also agree to HOLD HARMLESS AND INDEMNIFY Planet Swim from all claims resulting from all negligence of Planet Swim and to reimburse Planet Swim for any expenses incurred as a result of participation in a tennis program and presence at Planet Swim facilities. Participants further agree to pay all costs and attorneys' fees incurred by Planet Swim in investigating and defending a claim or suit but only if Participant's claim is withdrawn or to the extent an arbitrator determines that Planet Swim is not responsible for the injury or loss. Participants agree to hold harmless and indemnify Planet Swim from all claims and amounts related to legal and other action brought against Planet Swim for damages caused by Participant (for example, for damages caused by Participant while fighting with another participant).

**Severability and Venue:** Participants further expressly agree that this waiver is intended to be as broad and inclusive as is permitted by the law of the State of Florida and that if any portion thereof is held invalid, it is agreed that the remaining portion of the waiver will continue in full legal force and effect.

**Acknowledgment of Understanding:** Participants have read this waiver and fully understand its terms. Participants understand that they are giving up rights, including the right to compensation for injury resulting from negligence of Planet Swim. Participants acknowledge that they are signing the agreement freely and voluntarily and intend their signatures to be a complete and unconditional release of all liability to the greatest extent allowed by law. In signing this waiver as parent or guardian, I acknowledge that I am consenting to Participant's participation in a tennis program at Planet Swim and acknowledge that I understand that any and all risks, including that of negligence, whether known or unknown are expressly assumed by Participants and all claims, whether known or unknown, are expressly waived in advance.

## TO PARTICIPATE

**Assumption of Risks:** Physical activity, by its very nature, carries with certain dangers and risks that cannot be eliminated regardless of the care taken to avoid injuries. Planet Swim has programs for swimming and tennis and related activities such as strength training. Some of these activities involve strenuous exertions of strength using various muscle groups, some involve quick movements involving speed and change of direction, some involve contact with equipment, other participants and various surfaces, and others involve sustained physical activity which places stress on the cardiovascular system. Participants will also be exposed to risks while traveling and participating in various activities. Some of these activities involve travel in vehicles (for example, in vans when traveling to a competition or to the airport) and exposure to large crowds. The specific risks vary from one activity to another, but in each activity the risks range from (1) minor injuries such as scratches, cuts, bruises, and sprains to (2) major injuries such as loss of sight, loss of teeth, broken bones, joint or back injuries, concussions, and heart attacks to (3) catastrophic injuries including paralysis and death. I also understand that the Participant may expose others, or may be exposed, to contagious disease such as COVID-19, influenza, chicken pox, measles, etc. Participants have read the previous paragraphs and (1) understand the nature of the activities at Planet Swim, (2) understand the demands of those activities relative to the physical condition and skill level of Participant, and (3) understand the types of illnesses and injuries which may occur as a result of activities made possible by Planet Swim. Participants hereby assert that participation is voluntary, and that Participants knowingly assume all such risks.

**Acknowledgement of Rules and Standards of Conduct:** I understand that Planet Swim has rules and standards of conduct that are set forth in the Member Handbook and or instructed by the Management team. I agree to abide by these rules and standards for the safety of Participants, the Team Member, and the other participants.

# Policies

Effective as of August 2022

**Disclaimer:** Individuals and Families wishing to join the Planet Swim Tennis Club (PSTC) **must** have the registration and waivers properly filled out and signed by the member or legal guardian before the membership becomes effective.

## General Club Rules:

- All guests/non-members need to check in and pay their fees before they start to play.
- All players need to provide their own tennis balls; tennis baskets are for teaching purposes only.
- Use of professional tennis coaches for lessons on the courts who are not on the PSTC staff is strictly prohibited.
- Members have priority over Non-Member for all Clinics & Club Play sign-ups.
- Proper tennis attire is required: TENNIS SHOES are required, no running, black bottom, flip flops or dress shoes that mark the court will be allowed.
- SHIRTS and SHOES must be worn at all times on the courts and in the clubhouse. No bathing suits or sports bras are allowed.
- No beverages in glass containers, food, or gum are allowed on the courts.
- No food or drink is permitted in the lobby area.
- No paint or colored powder of any kind is allowed to be used on the court.
- No profanity will be permitted.
- Smoking/vaping is NOT permitted.
- All children under 14 years old must have on court adult supervision at all times.
- Balls are not to be hit against the building walls nor inside the building areas.
- Lockers are available during play only for our members. You must provide your own lock. You must empty your locker after play. Any Locker left overnight with a lock on it will be emptied by the Planet Swim Tennis Club and your contents will be donated.
- Please do not hit balls up against the windscreens nor court benches and chairs as target in any way.
- Parents are responsible for and must control their children with due regard to the comfort of other players. Children are not permitted to run unattended the club nor the lobby area.
- Adults taking tennis lessons must provide for supervision for their children. All children must be adult supervised on and off the courts.
- Only licensed service animals are permitted on the Planet Swim Tennis Club property.
- We reserve the right to refuse or turn away players who do not comply with the Planet Swim Tennis Club policies.
- Management shall have the authority to regulate the hours of operation, as it deems necessary.
- Planet Swim Tennis Club is not responsible for articles lost, stolen or mislaid.
- ALL USERS OF THE FACILITY ARE LIABLE FOR PROPERTY DAMAGED OR DESTROYED BY THEM.

**Communication:** Updates on program changes, cancellations, and news will be communicated through email. Please provide in a legible manner all email addresses you wish to be included for PSTC communications while filling your registration form. The online member portal may be used to book courts, spots in round robins and clinics, and to review accounts.

**Payment:** All membership dues, junior program dues, clinic fees and lesson fees will be added to your Planet Swim Tennis Club membership account. Payments are processed on the 1st day of the month and invoices are sent out by the last day of the previous month. **Non-members** must pay for their services at the check-in prior to their lesson or clinic.

**Refunds/Withdrawal:** Initiation fees and membership dues are non-refundable. Should you wish to discontinue your Planet Swim Tennis Club membership, please send an email to [billing@planetswim.org](mailto:billing@planetswim.org) requesting to place a hold on your account **by the last day of the month**. This request will prevent us from charging your account and will allow us to offer your spot to another member who might be on the waiting list. All cancellations **MUST** be done in writing to the email above. A **one-time** voluntary suspension of your membership is allowed for up to (6) months in extraordinary circumstances (temporary work re-assignment, prolonged serious injury/illness or hospital stay, pregnancy, family crisis, incarceration, etc..) Voluntary vacation every summer to another location will not be accepted. Upon re-activation of your membership, a re-activation fee equivalent to your annual renewal fee will apply. If the voluntary membership suspension extends past (6) months, the membership will be terminated.

**Court Reservation:** Only Members of the Planet Swim Tennis Club can reserve courts and courts can be reserved no more than a week in advance. Members may reserve a court by calling the tennis office (904-285-7545) or on our website ([tennisclub.planetswim.org](http://tennisclub.planetswim.org)). Members can only reserve one court at a time for no more than an hour and a half (1 ½) for singles and two hours (2) for doubles; additional playing time is based on court availability. Court time will be held for 15 minutes after the scheduled time, then "reassigned" if other players are waiting. Out of courtesy to other players, members are expected to cancel their court time as soon as possible. Failure to show or not to cancel several times may result in players losing their court reservation privileges.

**Adult Clinics/Group sessions:** The PSTC Open Adult Clinics consists of beginner, advanced-beginner, intermediate, and advanced level group clinics which provide players with the fundamental skills to develop a complete tennis game in preparation for league or tournament competition. Options for players include attending group clinics (1) day per week or (2) days per week. Players are required to choose which clinic day they want to come to and must stick to that day. Clinic days are **not** interchangeable. Members can sign-up online for their clinic session based on their clinic level. Non-members **MUST** call in to inquire about availability.

**Private Lessons:** Private lessons are an important part of a player's overall development and are available to members and non-members in 3 formats: private, semi-private and group. Lessons can be scheduled with the professional of your choice, at your convenience, based on the availability of the coach and courts. If the participant is a member, charges will be added and processed on their membership account. Non-members will be charged per lesson and **MUST** check-in and pay their fees at the front desk prior to each lesson. If a tennis lesson is missed and the PSTC staff is not notified up till 2 hours prior to the lesson starting time, the player will be billed at 50% of the lesson rate.

**Guest Pass/Guest/Non-members:** Members will receive (12) complimentary guest passes per year to be used for any non-member coming to the club to play as a guest of a member in good standing. Once these complimentary guest passes are used, members may still bring guests to the club for a charge of \$10 per guest, per day. All guests/non-members must complete at minimum, our Liability Waiver and COVID-19 waiver prior to play.

**Racquet Stringing:** All racquet stringing is done in-house. All Racquet Stringing Invoices are paid at the time of pick-up, payable to Planet Swim LLC. Please note, although frames are inspected for damage when they are handed in, we cannot guarantee the condition of the frame prior to stringing. Should frame damage occur as a result of normal stringing procedure, we cannot be held responsible. Although we try our best to have racquets ready within a 3-day turn around, some orders may require a longer turnaround time.

**Pro-shop Return/Exchange Policy:** If for any reason you are not completely satisfied with your product purchase, you are entitled to a full refund, exchange, or store credit within 15 days from the time of purchase with a receipt of your unused product. This policy does not apply to private, lessons, group lessons, membership. All Paid in Full Membership are non-refundable and non-transferable. Any item (s) that are returned more than 15 days from date of receipt WILL NOT BE ACCEPTED.

**Observation/Viewing Policy:** We kindly ask parents, siblings, and visitors to stay off of the off the court area during lessons. Lessons can be observed from outside of the fence or from the bleachers. Parents/Caretakers/Observers are not to talk to their children while in class. If you need to remove your child early from the class, please, either directly notify the instructor or speak with someone in the office to notify them for you.

**Ball Machine Rental:**

- There is no rental fee for PSTC Club Members
- Ball machine rental is for a minimum/maximum of 1.5-hour blocks at a time.
- A member may reserve the ball machine no more than 48 hours in advance. Court time must also be reserved with the ball machine.
- Ball machine rental must be done during Planet Swim Tennis Club office hours or via your CourtReserve Player Portal
- Children using the machine must have adult supervision on the court at all times.
- **For your safety please do not stand directly in front of the ball machine or aim balls directly at another person. Please do not hit balls directly at the ball machine. Please do not put hands into the ball machine.**
- Each member is responsible for picking up all of their balls and returning the machine and balls to the storage area.
- Please make sure to charge the ball machine after each use. If you don't know how, please ask the front desk.
